





1500 Capitola Road Request for Qualifications for Local Artist May 4, 2020 **New Deadline Below**

MidPen Housing, in collaboration with Santa Cruz Community Health (SCCH) and Dientes Community Dental (Dientes), is building a mixed-use community development which includes 57 units of affordable housing, 19,000-square-foot community medical clinic to be run by SCCH, with additional 1,200 square-foot retail pharmacy space, and an 5,000-square-foot community dental clinic to be run by Dientes.

The 1500 Capitola Way development will re-invigorate an historic site, formerly home to Robert Merriman, commander of the Abraham Lincoln Brigade. This was the brigade of American fighters who contributed to the Spanish Civil War leading up to World War II. Merriman became the inspiration for Robert Hemmingway's novel "For Whom The Bell Tolls". In addition, the former Live Oak ranchette sub-division, has an important agricultural economic history for the Santa Cruz County unincorporated area.

As a way of linking the new development to the multiple historical narratives attached to the site, the aforementioned development partners are commissioning two art features which will highlight the compelling Live Oak Neighborhood legacy for both the new residents, the existing neighbors and visitors to the clinics. We have planned a set of permanent display panels featuring a narrative and visual illustration of Robert Merriman and the Abraham Lincoln Brigade story. This feature is intended to highlight themes of volunteerism, social justice and community service which are evident in the biography of Robert Merriman and align closely with the missions of each of the three non-profit development partners. The partners envision an installation that will connect the shared values of both past and present:

- <u>SCCH</u>: To improve the health of our patients and the community, and advocate the feminist goals of social, political, and economic equality;
- <u>Dientes</u>: To create lasting oral health for the underserved children and adults of Santa Cruz County and neighboring communities.
- <u>MidPen:</u> To provide safe, affordable housing of high quality to those in need and to establish stability and opportunity in the lives of our residents.

Historic Narrative - The Storyteller:

For hire: a visual artist residing in Santa Cruz County, who can represent the story of Robert Merriman and the Abraham Lincoln Brigade, as well as the rural Live Oak neighborhood of Santa Cruz County that fostered this community. Per the County's land use requirements, this interpretive historical installation should honor the history of the Robert Merriman, including references to his role as Commander of the Lincoln Brigade, the historical importance of the Brigade in fighting fascism in Spain, and the use of Merriman as the inspiration for Robert







Jordan in Hemmingway's "For Whom the Bell Tolls." Further, to make a connection between his work and the use of the space to ensure access to essential needs (health and housing) as a human right, not a privilege.

The artist will be asked to distill this biographical and historic legacy to create a set of visuals that will animate permanent the display panels. The artist will consult with the development partners, local historians, photographs, books, etc. to generate the imagery and visual narrative content to honor the historical importance of the site as it lends itself to present day use. The artist may specialize in illustration, printmaking, painting, photo collage, digital design, or combinations thereof, with the goal of integrating historic data with the character and function of the renewed site functions. The design will be presented to the County Historical Resources Commission (HRC) for final approval.

In both the public plaza and along proposed Merriman Way, we will mount panels that feature elements of this historical narrative of the former Robert Merriman home and neighborhood, which will be displayed in a "wayfinding" configuration throughout the site.

<u>Application Process</u>: A jury made up of representatives from the three partners, a local historian, a member of the Santa Cruz County Arts Council (or a local artist), with the art consultant, will select two to three candidates from the pool of applicants for (online) interviews. Based on the artists' past accomplishments as well as their ability to address the history of the site, a finalist will be selected.
